GRANGE FARM, KIBWORTH BEAUCHAMP

On 19th January 2017 Leicestershire County Council confirmed the above Orders.

The effect of the Orders as confirmed (without modifications) is to divert the part of footpath Z97 which extends from Grid Reference 46928 29214 in generally south easterly and easterly directions for approximately 855 metres to Grid Reference 47005 29190.

The alternative routes will extend from Grid Reference 46928 29214 in an easterly direction for 285 metres to a point situated with a farm track at Grid Reference 46956 29215 and a further section from Grid Reference 46957 29194 in generally easterly, southerly and easterly directions for approximately 510 metres to Grid Reference 47005 29190.

Also to extinguish parts of footpath A98 from Grid Reference 46993 29249 in generally south easterly and east north easterly directions for approximately 330 metres to its junction with Harborough Road at Grid Reference 47023 29256 and a section of footpath A99 from Grid Reference 46996 29249 in a south westerly direction for approximately 25 metres to Grid Reference 46995 29247.

Also to create a new section of footpath A99 from Grid Reference 47000 29253 in a generally north easterly direction along the access road serving Grange Farm for approximately 245 metres to its junction with Harborough Road at Grid Reference 47018 29269 and a further section from Grid Reference 46993 29249 in generally south westerly and southerly directions along a farm track serving Grange Farm for approximately 985 metres to Debdale Lane (Field Road) at Grid Reference 46948 29170 as shown on the Order Maps.

A copy of the Orders as confirmed and the Order maps have been placed and may be seen free of charge at Room 200, County Hall, Glenfield and the offices of Harborough District Council, Symington Building, Adam and Eve Street, Market Harborough LE16 7AG during normal office hours. Copies have also been sent to the Clerks of Kibworth Beauchamp and Smeeton Westerby Parish Councils. Copies of the Orders and maps may be purchased at a cost of £15.

The Orders come into force on 18th February 2017 but if a person aggrieved by the Orders wants to question their validity, or that of any provision contained in them, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Orders, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from the date of this Notice, make an application to the High Court.
